Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA' long-term insurer financial strength and issuer credit ratings on **The First Insurance Co. Ltd.** The outlook on the ratings is stable. The ratings reflect our view of the insurer's very strong capital and earnings, adequate investment risk profile, as well as exceptional liquidity. First Insurance's moderate business scale in Taiwan's competitive non-life insurance market and less geographic business diversification compared with regional peers somewhat temper these strengths.
