

Research Update:

Delta Electronics Inc. Ratings Affirmed At 'twAA/twA-1+'; Outlook Stable

November 22, 2024

Rating Action Rationale

Taiwan Ratings Corp. today affirmed its 'twAA' long-term and 'twA-1+' short-term issuer credit ratings on **Delta Electronics Inc.** The outlook on the long-term rating is stable. The ratings mainly reflect the company's strong market position in the power electronics segment, as well as improving profit margin amid growing contribution from AI server power supply and thermal management solutions. Delta's weaker competitive position in the automation and energy infrastructure segment partly offsets these strengths.

The ratings also reflect our view that Delta will maintain a net cash position over the next one to two years, underpinned by its strong operating cash flow generation and abundant cash on hand.
