Yuanta Life Insurance Co. Ltd. 'twAA' Ratings Affirmed; **Outlook Stable**

January 17, 2025

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA' long-term insurer financial strength and issuer credit ratings on Yuanta Life Insurance Co. Ltd. The outlook on the ratings is stable. The ratings reflect our view that the insurer will remain a core member of the Yuanta Financial Holding Co. Ltd. group with strong support from the parent group, if needed. In addition, the ratings reflect our assessment that Yuanta Life will maintain strong control over its distribution network and a prudent investment appetite over the next one to two years. The insurer's small scale relative to other life insurance peers in the domestic market, and somewhat weak operating results partly offset these rating strengths.
