# Hon Hai Precision Industry Co. Ltd. Ratings Affirmed At 'twAA+/twA-1+'; Outlook Stable

October 28, 2019

## Rating Action Overview

Taiwan Ratings Corp. today affirmed its 'twAA+' long-term and 'twA-1+' short-term issuer credit ratings on **Hon Hai Precision Industry Co. Ltd.** The outlook on the long-term rating is stable. At the same time, we affirmed our 'twAA+' issue rating on the company's unsecured corporate bonds. The ratings on Hon Hai reflect the company's strong market position as the world's largest electronic manufacturing services provider, strong operating efficiency, an unrivalled vertically integrated production model, and very low debt leverage. The strengths are partly offset by the company's high customer concentration and heightening industry risks amid increasing competition and persistent margin pressure.
