

Research Update:

Taiwan Business Bank Ratings Affirmed At 'twAA-/twA-1+'; Outlook Stable

January 13, 2020

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA-' long-term and 'twA-1+' short-term issuer credit ratings on **Taiwan Business Bank**, as well as the 'twA-' issue credit rating on the bank's unsecured subordinated debentures. The outlook on the long-term rating is stable. The ratings on Taiwan Business Bank reflect our view of implicit support from the Taiwan government due to the bank's moderate systemic importance and government ownership. The ratings also reflect the bank's good market position in domestic small and mid-size enterprise loan business. Counterbalancing these strengths is the bank's moderate profitability compared with that of regional players and slightly weaker risk management record compared with similar domestic peers.
