# TECO Electric & Machinery Co. Ltd. Ratings Affirmed At 'twA+/twA-1'; Outlook Stable

February 18, 2020

## **Rating Action Overview**

Taiwan Ratings Corp. today affirmed its 'twA+' long-term and 'twA-1' short-term isuer credit ratings on **TECO Electric & Machinery Co. Ltd.** The outlook on the long-term rating is stable.

The ratings reflect the stable market position and improving product mix for TECO's motor business, which further support the low volatility of the company's profitability. The ratings also reflect our view of TECO's strong and sustainable free operating cash flow and low debt leverage. These strengths are partly offset by the company's high profit concentration on motor business, slightly weaker technology capabilities and product mix than its global peers, and relatively weaker performance on non-motor business.
