

Research Update:

Taiwan Sugar Corp. Ratings Affirmed At 'twAA-/twA-1+'; Outlook Stable

March 17, 2021

Rating Action Overview

Taiwan Ratings Corp. today affirmed its 'twAA-' long-term and 'twA-1+' short-term issuer credit ratings on **Taiwan Sugar Corp.** The outlook on the long-term rating is stable. The ratings reflect the company's large low-cost land bank for land development and land disposal, as well as Taiwan Sugar's net cash position and exceptional liquidity. The company's still-weak profitability in non-land development businesses partly offsets these rating strengths. Taiwan Sugar's weak profitability is mostly due to the company's policy burden to help maintain social stability through rent subsidies and local market stability for sugar and hog products. It also reflects the company's high cost structure resulting from its government-owned enterprise status. In addition, the ratings on Taiwan Sugar reflect our view of the moderately high likelihood of extraordinary support from the Taiwan government, if needed.
