

Research Update:

E.SUN Commercial Bank Ltd. Ratings Affirmed At 'twAA+/twA-1+'; Outlook Stable

June 29, 2021

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA+' long-term and 'twA-1+' short-term issuer credit ratings on **E.SUN Commercial Bank Ltd.**, as well as our issue credit ratings on the bank's unsecured subordinated bonds. The outlook on the long-term rating is stable.

The ratings reflect our assessment of the E.SUN Bank's strong capitalization, satisfactory fee income contribution with satisfactory management and execution of business strategies, and adequate risk position with good loss record. The ratings also reflect a notch of government support, given our assessment of the bank's moderate systemic importance to Taiwan's banking system. Counterbalancing these strengths are the bank's moderate geographic diversity and profitability compared with those of other regional banks.
