

Research Update:

HSBC Bank (Taiwan) Ltd. Ratings Affirmed At 'twAAA/twA-1+'; Outlook Stable

June 29, 2021

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAAA' long-term and 'twA-1+' short-term issuer credit ratings on **HSBC Bank (Taiwan) Ltd.** The outlook on the long-term rating is stable. At the same time, we affirmed our 'twAAA' issue credit rating on the bank's unsecured senior debentures. The ratings on HSBC Bank (Taiwan) reflect our view of potential support from the bank's immediate parent group, The Hongkong and Shanghai Banking Corp. Ltd., if needed, given the bank's role as a highly strategically important subsidiary. We believe it is highly likely the bank's integration with the group in terms of risk control and operations will remain high over the next two years and we see the parent is highly unlikely to divest of HSBC Bank (Taiwan) over the same period.
