Hotai Insurance Co. Ltd. Ratings Affirmed At 'twAA'; Outlook Stable

February 21, 2022

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA' long-term financial strength and issuer credit ratings on Taiwan-domiciled **Hotai Insurance Co. Ltd.** The outlook on the ratings is stable. The ratings on Hotai Insurance reflect our view that the insurer will remain insulated from its parent, Hotai Motor Co. Ltd. group under the current regulatory oversight. On a stand-alone basis, we forecast Hotai Insurance's capital and earnings will remain strong, supported by the insurer's earnings retention and adequately managed risk profile, including its investment on higher risk assets. We also believe Hotai Insurance's operating performance will remain stable, underpinned by adequate underwriting controls as the insurer pursues above-average growth in the domestic property and casualty market.
