

Research Update:

Taiwan Water Corp. Ratings Affirmed At 'twAAA/twA-1+'; Outlook Stable

March 16, 2022

Rating Action Overview

Taiwan Ratings Corp. today affirmed its 'twAAA' long-term and 'twA-1+' short-term issuer credit ratings on **Taiwan Water Corp.** The outlook on the long-term rating is stable.

The ratings on Taiwan Water reflect our view of the almost certain provision of timely and sufficient extraordinary financial support to the company by the Taiwan government, if Taiwan Water has financial distress. This is because of Taiwan Water's critical role to supply sufficient and reliable water to support Taiwan's highly industrialized economy. We also believe that Taiwan Water will remain integrally linked with the central government of Taiwan. In addition, we forecast Taiwan Water's stand-alone credit profile will remain stable over the next two years. Taiwan Water is likely to maintain a sufficient buffer for its interest coverage ratio to support the company's financial strengths, largely thanks to its status as government-own enterprise, despite of its rising debt and weakening profitability.
