# Hua Nan Financial Holdings Co. Ltd. Ratings Affirmed At 'twAA-/ twA-1+; Outlook Stable

## Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA-' long-term and 'twA-1+' short-term issuer credit ratings on **Hua Nan Financial Holdings Co. Ltd.**

The ratings reflect our assessment of Hua Nan Financial Holdings group's strong capitalization, good domestic market positions supported by an established banking franchise, as well as satisfactory funding and liquidity profile. Counterbalancing factors include competitive pressure on the group's profitability and the group's relatively concentrated revenue stream compared with global peers'.
