# SinoPac Securities Corp.'s Upcoming Series 111-1 Unsecured Subordinated Debentures Rated 'twA+'

May 11, 2022

## Rating Action

Taiwan Ratings Corp. today assigned its 'twA+' issue rating to **SinoPac Securities Corp.'s** (twAA-/Stable/twA-1+) proposed series 111-1-A, seven-year unsecured subordinated debentures and 111-1-B ten-year unsecured subordinated debentures. The amount of the issuance will be about new Taiwan dollar (NT\$) 400 million and 600 million, respectively. SinoPac Securities will use the funds raised from the issuance to enhance its capital adequacy and its funding structure. Any material change in the proposed terms, conditions or amount of the issuer could affect the rating.

## Rationale

The rating on the Series 111-1 unsecured subordinated debentures is one notch below the long-term issuer credit rating on SinoPac Securities due to the issue's subordinated feature.

The Series 111-1 bonds rank senior to SinoPac Securities Corp.'s ordinary shares and junior to the company's senior liability holders, with respect to the payment of interest and relevant amounts upon liquidation.
