

Research Update:

China Development Financial Holding Corp. Ratings Affirmed At 'twAA-/twA-1+; Outlook Stable

August 18, 2022

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA-' long-term and 'twA-1+' short-term issuer credit ratings on **China Development Financial Holding Corp.** (CDFHC). At the same time, we affirmed our 'twA' issue credit rating on CDFHC's debts. The outlook on the long-term ratings is stable.

Our assessment of the CDFHC group credit profile reflects the consolidated credit profile of **China Life Insurance Co. Ltd., KGI Bank, and KGI Securities Co. Ltd.,** and our view that the insurer dominates the overall group credit profile. Therefore, the ratings on the various group units will move in tandem with ratings on China Life. The outlook on CDFHC reflects our view that China Life's overall credit profile will remain stable with satisfactory capital and earnings over the next one to two years. At the same time, we believe the group will record an industry average operating performance, gradually improve its double leverage ratio, and the key subsidiaries will maintain their current capitalization over the same period. The double leverage ratio measures the proportion of the holding company's equity investment in its subsidiaries to total shareholders' equity.
