# Bank of Taiwan Ratings Affirmed At 'twAAA/twA-1+'; Outlook Stable

September 29, 2022

## **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twAAA' long-term and 'twA-1+' short-term issuer credit ratings on **Bank of Taiwan**. The outlook on the long-term rating is stable. At the same time, we affirmed the issue ratings on the bank's various unsecured subordinated debentures (see ratings list).

The ratings on Bank of Taiwan reflect our view of an extremely high likelihood that the Taiwan government would provide timely, sufficient, and extraordinary support to Bank of Taiwan, as needed. The ratings also reflect the bank's solid domestic franchise and strong customer base with superior funding profile, despite of below-average profitability compared with domestic peers.
