# Hotai Insurance Co. Ltd. 'twAA-' Ratings Withdrawn At Issuer's Request; CreditWatch Unresolved At Time Of Withdrawal

November 8, 2022

# **Rating Action**

Taiwan Ratings Corp. today withdrew its 'twAA-' long-term issuer credit rating and financial strength rating on **Hotai Insurance Co. Ltd** at the issuer's request.

## Rationale

The ratings have been on CreditWatch with negative implications since June 8, 2022. The placement of the ratings on CreditWatch reflected our view of uncertainty surrounding Hotai Insurance's overall creditworthiness. We estimate the insurer's losses on total pandemic claims could lead to a material drop in its total adjusted capital in the absence of sufficient capital replenishment. Without proactive capital management and asset adjustment in place, the issuer's capitalization and liquidity will be subject to high downside pressure.

Taiwan Ratings was unable to resolve the CreditWatch placement and determine accurate final ratings before the withdrawal because we lacked necessary information at the time of the request to withdraw the ratings.
