

Research Update:

Chunghwa Telecom Co. Ltd. Ratings Affirmed At 'twAAA/twA-1+'; Outlook Stable

November 21, 2022

Rating Action Rationale

Taiwan Ratings Corp. today affirmed its 'twAAA' long-term and 'twA-1+' short-term issuer credit ratings on **Chunghwa Telecom Co. Ltd.** The outlook on the long-term rating is stable. We affirmed the ratings on Chunghwa Telecom to reflect our view that the telecom provider will maintain its market leadership, robust cash flow generation, and sound financial management over the next one to two years. We also expect Chunghwa Telecom to maintain low debt leverage over the same period. These strengths are partly offset by the competitive market condition in Chunghwa Telecom's mobile and broadband businesses, as well as the continued decline in the company's voice revenue.
