

Research Update:

Delta Electronics Inc. Ratings Affirmed At 'twAA/twA-1+'; Outlook Stable

January 18, 2023

Rating Action Rationale

Taiwan Ratings Corp. today affirmed its 'twAA' long-term and 'twA-1+' short-term issuer credit ratings on **Delta Electronics Inc.** The outlook on the long-term rating is stable.

The ratings reflect Delta's leading market share in the global power supply and thermal component markets for information technology applications, significant business diversity across power electronics, automation and power infrastructure, and strong and sustainable free operating cash flow. The ratings also reflect our view that Delta could maintain a net cash position over the next two years, based on its still-robust profitability, despite elevated capital expenditure and working capital needs. Several factors temper these strengths. These include Delta's smaller scale and narrower product and service offerings than leading global automation & power infrastructure peers, intense industry competition, and Delta's weaker supply chain for its developing electric vehicle and automation businesses. In addition, the company faces significant cyclical and rapid product evolution in the technology sector.
