

Research Update:

Yuanta Life Insurance Co. Ltd. Ratings Affirmed At 'twAA'; Outlook Stable

January 18, 2023

Rationale

Taiwan Ratings Corp. today affirmed its 'twAA' long-term insurer financial strength and issuer credit ratings on Taiwan-domiciled **Yuanta Life Insurance Co. Ltd.** The outlook on the ratings is stable. The ratings reflect our view that the insurer will remain a core member of the parent **Yuanta Financial Holding Co. Ltd.** group with strong support from the parent. In addition, the ratings reflect our assessment that Yuanta Life will maintain strong control over its distribution network and a prudent investment appetite over the next one to two years. Partly counterbalancing these strengths are the insurer's small scale relative to other life insurance peers in the domestic market, and below-average, albeit improving operating results.
