Union Finance & Leasing (Int'l) Corp. Ratings Affirmed At 'twA/twA-1'; Outlook Stable

Rating Action

Taiwan Ratings Corp. today affirmed its 'twA' long-term and 'twA-1' short-term issuer credit ratings on **Union Finance & Leasing (Int'l) Corp.** The outlook on the long-term rating is stable to reflect our view that the parent, **Union Bank of Taiwan**, would provide the company with some financial support, if needed, given the leasing subsidiary plays a strategically important role within the parent group. Therefore, the ratings on Union Finance & Leasing will move in tandem with the parent's credit profile. In addition, the ratings reflect the company's strong capitalization relative to its overall risk profile. Counterbalancing factors are Union Finance & Leasing's moderate risk controls and relatively small market share compared with that of leading competitors.
