# KGI Securities Co. Ltd.'s Upcoming Series 113-1 Subordinated Corporate Bond Rated 'twAA-'

# **Rating Action**

Taiwan Ratings Corp. today assigned its 'twAA-' issue rating to **KGI Securities Co. Ltd.'s** (twAA/Stable/twA-1+) Series 113-1 ten-year unsecured subordinated corporate bond. The amount of the issuance will be up to about new Taiwan dollar (NT\$) 3 billion. KGI Securities will mainly use the funds raised from the corporate bond to support its business development and improve its regulatory capital adequacy ratio. The rating reflects the bond's subordinated status. Any material change in the proposed terms, conditions, or amount of this issue could affect the rating.
