BNP Paribas, Taipei Branch Ratings Affirmed At 'twAAA/twA-1+'; Outlook Stable

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAAA' long-term and 'twA-1+' short-term issuer credit ratings on **BNP Paribas**, **Taipei Branch (BNP Taipei)**. The outlook on the long-term rating remains stable. The ratings on BNP Taipei reflect our view that its parent, France-based BNP Paribas (rated 'A+/Stable/A-1' by S&P Global Ratings) would ensure full and timely payment of the Taipei branch's obligations, if needed. The ratings and outlook on BNP Taipei will move in tandem with those on its parent.


