# MSIG Mingtai Insurance Co. Ltd. Ratings Affirmed At 'twAAA'; Outlook Stable

May 16, 2024

## Rationale

Taiwan Ratings Corp. today affirmed its 'twAAA' long-term financial strength rating and issuer credit rating on **MSIG Mingtai Insurance Co. Ltd.** The outlook on the ratings is stable. The ratings on MSIG Mingtai Insurance reflect the company's very strong capital and earnings and satisfactory brand and reputation benefiting from a good local market position and franchise, as well as brand association with its Japan-based parent group. The ratings also benefit from strong group support, given our view of MSIG Mingtai as a highly strategic entity to the parent group. Several factors temper these strengths, including the insurer's business concentration in Taiwan's non-life sector with limited geographic diversification and small capital base relative to its international peers, which are common attributes of Taiwan-based non-life insurers.
