# Hua Nan Assets Management Co. Ltd. Ratings Affirmed At 'twA+/twA-1'; Outlook Stable

June 3, 2024

## **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twA+' long-term and 'twA-1' short-term issuer credit ratings on **Hua Nan Assets Management Co. Ltd.** (Hua Nan AMC). The outlook on the long-term rating is stable. The ratings on Hua Nan AMC reflect our expectation of strong support from the company's financially stronger parent Hua Nan Financial Holdings Co. Ltd., based on our view of Hua Nan AMC's strategically important role within the group. The ratings also reflect the asset management company's adequate capitalization, funding, and liquidity, with support from group resources and the company's extensive experience in urban renewal development.

Counterbalancing factors include the limited operating scale of Hua Nan AMC in Taiwan's finance and leasing industry, and moderate risk position due to risk concentration on the property-related business.
