Research Update:

Yulon Finance Corp. Ratings Affirmed At 'twA-/twA-2'; Outlook Positive

June 11, 2024

Rating Action

Taiwan Ratings Corp. today affirmed its 'twA-' long-term and 'twA-2' short-term issuer credit ratings on Yulon Finance Corp. The outlook on the long-term rating remains positive. The ratings on Yulon Finance reflect the company's strong business position in the domestic car financing and leasing sectors, strong capitalization relative to risk profile, and adequate funding and liquidity profile. Yulon Finance's moderate risk control framework compared to that of local banks somewhat tempers these strengths.

We view Yulon Finance's stand-alone credit characteristics to be superior to those of the parent Yulon Motor Co. Ltd. group. In addition, we assess Yulon Finance to be an insulated entity within the group, which allows for a one notch uplift to the issuer credit rating on Yulon Finance above the group credit profile.
