Research Update:

E.SUN Financial Holding Co. Ltd. Ratings Affirmed At 'twAA-/twA-1+'; Outlook Stable

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA-' long-term and 'twA-1+' short-term issuer credit ratings on **E.SUN Financial Holding Co. Ltd.** (E.SUN FHC). The outlook on the long-term rating is stable.

The consolidated credit profile of the E.SUN FHC group reflects the stand-alone credit profile of **E.SUN Commercial Bank Ltd.** (E.SUN Bank), the flagship and dominating subsidiary of the group. In our view, E.SUN Bank's strengths include strong capitalization, satisfactory fee income contribution with satisfactory management and execution of business strategies, and adequate risk position with good loss record. Counterbalancing factors include the bank's relatively small business scale with less geographical diversification by international standards. The ratings on the holding company reflect its subordination to its core operating subsidiary, E.SUN Bank.
