# Shinshin Credit Corp. Ratings Affirmed At 'twA-/twA-2'; Outlook Positive

June 20, 2024

## **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twA-' long-term and 'twA-2' short-term issuer credit ratings on **Shinshin Credit Corp.** The outlook on the long-term rating remains positive. The ratings on Shinshin Credit reflect our view of potential support from the company's immediate parent, **Yulon Finance Corp.**, if needed, given its core status to the parent.

In addition, the ratings reflect our view of the company's good market position in commercial vehicle financing and increasingly diversified business mix, as well as strong capitalization to support its growth appetite in corporate financing services and energy development. However, Shinshin Credit's moderate risk control framework compared to that of local banks tempers these strengths.
