Uni-President Enterprises Corp. Ratings Affirmed At 'twAA/twA-1+'; Outlook Stable

June 25, 2024

Rating Action Rationale

Taiwan Ratings Corp. today affirmed its 'twAA' long-term and 'twA-1+' short-term issuer credit ratings on **Uni-President Enterprises Corp.** The outlook on the long-term rating is stable.

The ratings on Uni-President reflect the company's good business diversity with solid market positions in Taiwan's food and beverage and convenience store sectors. The ratings also reflect our view that the company is likely to maintain its sustainable discretionary cash inflow over the next two years despite aggressive capital expenditure over the same period. This should enable Uni-President to maintain the ratio of debt to EBITDA at 2.0 x-2.5x over the period.

Counterbalancing these rating strengths are the higher industry risk in China's food and beverage market due to intense competition and volatile material costs, and weaker performance on the company's other smaller non-food and beverage businesses.
