Carplus Auto Leasing Corp. Ratings Affirmed At 'twA-/twA-2', Outlook Remains Positive

June 27, 2024

Rating Action

Taiwan Ratings Corp. today affirmed its 'twA-' long-term and 'twA-2' short-term issuer credit ratings on **Carplus Auto Leasing Corp.** The outlook on the long-term rating is positive. The ratings on Carplus mainly reflect our view of the company as a core subsidiary of the parent, **Yulon Finance Corp.** group, as well as Carplus' strong business position in the domestic auto leasing market and strong capital position. The company's moderate risk controls compared with domestic banks partly offsets these strengths.

We believe that as a core subsidiary of Yulon Finance, Carplus will receive necessary support from its parent; therefore, the ratings on Carplus will move in tandem with our assessment of Yulon Finance's credit profile.
