Bank of Panhsin Ratings Affirmed At 'twBBB/twA-2; Ratings Then Withdrawn At The Company's Request

Rating Action

Taiwan Ratings Corp. today affirmed its 'twBBB' long-term and 'twA-2' short-term issuer credit ratings on Bank of Panhsin. We then withdrew the ratings at the company's request.

The ratings affirmation prior to the withdrawal reflects our view of the bank's adequate funding and liquidity profile, partly offset by its small business scale, higher-than-average risk appetite, and improving, albeit still below-average capitalization. The rating outlook at the time of the withdrawal was positive.
