KGI Bank Ratings Affirmed At 'twAA/twA-1+'; **Outlook Stable**

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA' long-term and 'twA-1+' short-term issuer credit ratings on KGI Bank. The outlook on the long-term rating is stable.

The ratings on KGI Bank reflect our view of a high likelihood of support from the parent KGI Financial Holding Co. Ltd. group, given the bank's core group status. The ratings also reflect KGI Bank's strong capitalization supportive by prudent capital policies and proactive capital management, and its adequate funding and liquidity profile. KGI Bank's higher growth appetite in small and mid-size enterprises and other consumer lending as well as moderate profitability by global standards temper these strengths.
