He Jing Co. Ltd. Ratings Affirmed At 'twA+/twA-1'; Outlook Stable

Rating Action

Taiwan Ratings Corp. today affirmed its 'twA+' long-term and 'twA-1' short-term issuer credit ratings on **He Jing Co. Ltd.** The outlook on long-term rating is stable.

The ratings on He Jing reflect our view of a high likelihood of support from its parent, **Hotai Finance Co. Ltd.**, given the subsidiary's highly strategic role within the parent group. The ratings also reflect our view that He Jing's market share will expand through resource support from Hotai Finance and business association with the Hotai Motor Co. Ltd. group, as well as He Jing's strong capitalization relative to its risk exposure. The company's short operating record, concentrated business lines, and moderate risk control framework compared with local banks temper these strengths.
