Research Update:

Mega International Commercial Bank Ratings Affirmed At 'twAAA/twA-1+' On Strong Capitalization; Outlook Stable

September 24, 2024

Rationale

Taiwan Ratings Corp. today affirmed its 'twAAA' long-term and 'twA-1+' short-term issuer credit ratings on **Mega International Commercial Bank Co. Ltd.** (Mega Bank). The outlook on the long-term rating is stable.

The ratings on Mega Bank reflect the bank's well-established franchise, especially in Taiwan's foreign exchange and offshore banking businesses, above-average overseas diversification, and strong capitalization. The ratings also reflect the bank's adequate funding and liquidity supported by its strong corporate banking franchise.

In addition, the ratings reflect a high likelihood of support from the government of Taiwan in times of distress, given the bank's high systemic importance in Taiwan's financial sector, and the bank's policy role to provide offshore banking services and handle government foreign financial matters. These strengths are somewhat tempered by the bank's slightly moderate profitability by international standards and potential competition as other domestic banks expand their foreign currency businesses.
