# **Rating Action**

Taiwan Ratings Corp. today assigned its 'twA+' issue rating to **Hua Nan Securities Co. Ltd.'s** (twAA-/Stable/twA-1+) Series 113-1 ten-year unsecured subordinated corporate bond. The amount of the issuance will be up to about new Taiwan dollar (NT\$) 2 billion. Hua Nan Securities will mainly use the funds raised from the corporate bond to enhance its regulatory capital adequacy ratio. The rating reflects the bond's subordinated status. Any material change in the proposed terms, conditions, or amount of this issue could affect the rating.
