Rating Action

Taiwan Ratings Corp. today assigned its 'twAA-' issue credit rating to **Nan Shan Life Insurance Co. Ltd.'s** (twAA/Stable/--) proposed Series 113-2 (A) unsecured subordinated corporate bond. The tenor of the issuance is ten years. The main purpose of the issuance is to enhance Nan Shan Life's regulatory adequacy ratio. The issue rating reflects the bond's subordinated status. Any material changes in the proposed terms and conditions or amount of this issue could affect the rating.
