## **Research Update:**

## Shinkong Insurance Co. Ltd. Ratings Affirmed At 'twAA+'; Outlook Stable

November 27, 2024

## Rationale

Taiwan Ratings Corp. today affirmed its 'twAA+' long-term insurer financial strength and issuer credit ratings on **Shinkong Insurance Co. Ltd.** The outlook on the ratings is stable. The ratings on Shinkong Insurance continue to reflect our view of the insurer's strong competitive position as indicated by its favorable underwriting performance. The ratings also reflect the insurer's very strong capital and earnings which provide a good buffer for moderate market volatility. Shinkong Insurance is the third largest property and casualty insurer in Taiwan; however, the insurer's smaller scale and less geographic business diversification than its international peers somewhat counterbalance its rating strengths.
