Union Bank of Taiwan Ratings Affirmed At 'twA+/twA-1'; Outlook Stable

December 12, 2024

Rating Action

Taiwan Ratings Corp. today affirmed its 'twA+' long-term and 'twA-1' short-term issuer credit ratings on **Union Bank of Taiwan**. The outlook on the long-term rating is stable. Our ratings on Union Bank reflect the bank's strong capital base relative to risk profile, as well as good asset quality and adequate funding and liquidity profile. However, Union Bank's relatively small presence in the domestic market and above-average investment appetite somewhat offset these strengths.
