# China Steel Structure Co. Ltd. Ratings Affirmed At 'twA-/twA-2'; Outlook Negative

May 22, 2025

## **Rating Action Rationale**

Taiwan Ratings Corp. today affirmed its 'twA-' long-term and 'twA-2' short-term issuer credit ratings on **China Steel Structure Co. Ltd.** The outlook on the long-term rating is negative.

The ratings on China Steel Structure reflect the company's good position in the domestic steel structure market, and our view that the company is a strategically important member of its parent, China Steel Corp. group. However, several factors offset these credit strengths. These include China Steel Structure's highly competitive steel structure and engineering and construction businesses, smaller revenue base, volatile debt leverage amid fluctuating working capital needs, and heavy reliance on short-term debt that results in less-than-adequate liquidity.
