# FSITC Taiwan Money Market Fund Rating Affirmed At 'twAAf'

March 19, 2026

## Rating Action

Taiwan Ratings Corp. today affirmed its 'twAAf' fixed-income fund credit quality rating on **FSITC Taiwan Money Market Fund**. The rating reflects our view of the very strong credit quality of the fund's portfolio exposure relative to that of funds in the Taiwan market. This very strong credit quality is supported by the track record of the fund's credit score that has been within our rating threshold rating with a decent buffer. We base our quantitative assessment of the fund's portfolio quality on the tenor and the rating of the invested entities according to our criteria.

Additional support comes from our view of that the fund manager's investment strategy, portfolio allocation, duration management, liquidity management and risk guidelines in response to market dynamics, among other factors can consistently support the rating level of 'twAAf' over the next few years. Other supporting factors include strong risk management and compliance; adequate management and organization, credit culture and credit research of the fund house, no indicators gauging potential rating volatility, and stringent regulations bolstering the fund's credit quality and management strength. The industry risk of market-sensitive fund size fluctuation tempers these rating strengths.
